3. That the said school is being run by **NOVA KALVI ARAKATTALAI** a registered Trust, registered under the Trust Act, having its registered office at **No.29, Gurusamy Road, Chetpet, Chennai – 600031.**, and the **“Trust is of a Non-Proprietary Character in nature”**.
4. That no member of the School Management Committee is related to each other.
5. That the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
6. That no part of income from the institution shall be diverted to any individual in the Trust/Society/Company registered under section 25 of the companies act, 1956, School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school.
7. That the school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
8. That the school will not open classes under CBSE pattern particularly class IX /X /XI /XII and will not use CBSE name in any manner without obtaining affiliation.

9. That the Principal and Correspondent / Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the circular issued by the board from time to time. The school under takes to abide by the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

10. That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour Laws etc., with respect to the school and staff of the school.

11. That the school will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene certificate are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

12. That the school will ensure that all required infrastructure is available with the school before starting classes.

13. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation – bye laws are available with the school before starting classes.

14. That the school will follow the provisions related to fee contained in affiliation–byelaws and will disclose the details of fee to the students/ parents every year before start of session without restoring to any hidden charges in the heads of fee.

15. That the school will not coerce any student / parent to buy books / stationary / uniform from any particular shop.

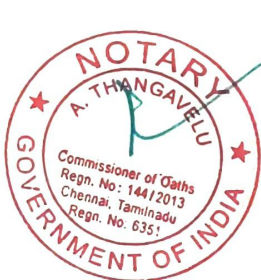
